



### States rely on sales tax revenue

Total state government tax collections



 Sales tax makes up 47% of total state revenue

### Compliance is not optional

### When must businesses collect sales tax?

It all comes down to nexus

- The connection that establishes a business obligation to collect and remit tax is known as nexus.
- Until this connection is established, the taxing jurisdiction cannot impose its sales taxes on a business.
- Many business activities can create nexus (see table).

### Tax Law Changes by the Numbers

### **Economic Nexus**

- 21 states adopted economic nexus as of December 31, 2018, requiring out-of-state businesses with a certain amount of economic activity in the state to collect and remit sales tax
- 43 states are now enforcing economic nexus
- Missouri and Florida are the two hold-out states

### Evaluating Nexus – Physical Presence is Still There

The triggers that obligate you to collect sales tax in a state


- Nexus is the connection between a business and a taxing authority that requires the business to submit itself to the jurisdiction of that authority.
- Types of nexus for remote sellers:
  - Property
  - Employees
  - Click-through
  - Affiliate
  - Economic
  - Marketplace


